Food service. After considering several options and with what's happening (or could happen) with COVID-19, costs associated with operating our own kitchen, etc., the Clubhouse Committee has selected to have "Chow Hound" mobile food truck concession operate in our main parking lot while we operate our own beverage cart as well as having limited snacks/beverages available inside the clubhouse. This choice was not an easy one to make, however after considering member concerns about wages and to keep our costs as low as possible while providing food service, is deemed to be the best one for 2020. They will begin operations this Saturday from 10am-6pm (May 30) and intend to be available during busier

times such as our league times and weekends provided they are supported by sales. Should AHS/Provincial protocols relax further, there is the option (with all parties in agreement) to have them cater events (tournaments, etc).

League play and socials. Now that food service has been arranged, we are looking in early June to begin our league play subject to carefully following AHS/Provincial protocols so please check our website frequently for more details. At this time we are limited to a maximum of 50 participants for outside activities (including staff), physical distancing on the course and while eating, only sharing carts/tables with members of your immediate household, etc. Thank you for your patience and understanding for the delay and possible format change to ensure compliance with AHS/Provincial protocols.

I'm sure that you are aware, but just a reminder, your board is a group of volunteers that were voted in by a majority to oversee and provide guidance to the General Manager and the operations of the golf course and camping. We have paid the same amounts as other members to enjoy the amenities that BGCC provides.
