MANAGERS REPORT

- Golf for Cancer was well attended. Weather was very cool and wet. There are still some final donation cheques to come in to determine funds raised for the Bashaw Health and Wellness cancer fund

- Have had several government inspectors conducting inspections and assessments at the club to ensure we are adhering to regulations set out as required
- Play has been way down due to poor weather conditions
- Therma couplers had failed on both hot water heaters and have been replaced
